Oversubscription criteria – year 12

For enrolment on all courses the requirements are five GCSEs (or equivalent) at grade 5 or above, including English and mathematics. Each course also has recommended entry requirements which can be accessed via the academy website: www.walton-ac.org.uk/sixth-form/courses.

Special consideration will be given for individual cases.

Sometimes we may be able to offer a place in year 12, but not your preferred combination of subjects. If we cannot offer the preferred subjects we will offer a place for an alternative combination of subjects.
